General Notes

- 1. <u>New schools require a full educational specification</u>. If the school uses the same educational delivery system as other district schools, Component 1 Educational Programs and Delivery System needs to be completed only for the first project and simply referenced on subsequent schools.
- <u>Major Renovation / Addition</u> <u>Extensive</u> renovation, replacement or reconfiguration of spaces to meet code requirements as well as current and future educational program requirements. This may include adding additional space, reconfiguration of existing space, replacement or upgrades to: structural, handicapped accessibility, HVAC, roofing, electrical, windows, flooring, ceiling, lighting, technology, infrastructure.
- 3. <u>Minor Renovation / Addition</u> <u>Selective</u> upgrades of some systems or building components such as repair, replacement, or refurbishment of: technology (wiring and infrastructure), roofing, flooring, ceiling, lighting, electrical upgrades, painting, or minor additions or reconfiguration of space.
- 4. All charter schools require a full educational specification (all components) including how the educational specification relates to the approved charter of the school.

5. Portable replacement - simply replaces portables with permanent construction - no change in educational programs or delivery.
