## Introduction

This section discusses the goals for the desired future state of the district's educational programs and facilities.

This document is a Facilities Master Plan (FMP) Update for Gallup-McKinley County Schools (GMCS). The intent of the plan is to guide capital planning decisions to support the district's educational mission and meet state adequacy standards. The Public School Capital Outlay Council (PSCOC)/Public School Facilities Authority (PSFA) requires that all New Mexico public school districts have a five-year facility master plan as a prerequisite for eligibility to receive state capital outlay assistance. This master plan update is in accordance with guidance issued by the PSCOC/PSFA.

The Facilities Master Plan serves as a flexible tool to present issues to the community, board of education, and district staff for input and revision on a periodic basis. Preparation of the FMP used a systematic process that strives to identify needs and wisely allocate capital resources to bring district facilities up to state adequacy standards and district policies with respect to:

- Life/health/safety
- Educational/programmatic needs (additions and remodeling to meet various educational standards) and curriculum needs
- Renewal needs (replacement schools, remodeling, refurbishing, planning studies, deferred maintenance, and major system replacement)
- Provision for necessary growth (new schools, additions, remodeling, site acquisition, and design planning studies)
- Educational technology



The FMP addresses four major questions:

- Where do we want to be? identifies district facility goals.
- Where are we now? identifies the adequacy of district facilities and capacity to meet future needs.
- Where we are going? analyzes information about future enrollment, program changes, classroom needs and financial resources.
- How do we get there? identifies the gaps between existing conditions and the ideal future state, develops a strategy to meet needs, and presents a prioritized list of capital projects.

The master plan has four sections:

- Section 1 Goals / Process provides information about district goals and the master planning process.
- Section 2 Existing and Projected Conditions provides information about district facilities, demographics, enrollment, technology and capital resources.
- Section 3 Capital Improvement Plan provides information about capital needs, district priorities and capital strategies.
- Section 4 Master Plan Support Material and Appendix provides detailed information about district school and support facilities, growth/enrollment/ utilization, facility evaluation and cost estimating data.

# 2 Existing and Projected Conditions

This section provides an overview of the district's current educational programs and facilities configuration, and community involvement.

## 2.1 Programs

Gallup-McKinley County Schools programs serve 11,631 students in the 2018/19 school year from preschool through grade 12, including programs for students through age

determined by eligibility for Free or Reduced Price Lunch Program; 100% of students in the GMCS Local Education Agency (LEA) were economically disadvantaged in the 2017/18 school year. PED reports that 78.9% of students are Native American; 28.6% are English Language Learners (ELL).

The New Mexico Public Education Department (PED) grades the school educational programs. Overall, school grades

22 to graduate and learn life skills.

GMCS offers a full day preschool and pre-K program. The preschool program is a federally funded program (through IDEA) to provide services to children with identified developmental delays starting at age 3. The students have an individualized education program (IEP), allowing facilities to receive

#### 2.1.2 Assumptions / Anticipated Changes in Programs

Since its last FMP, the district continued its capital program to replace older elementary schools in partnership with the state PSCOC. Washington ES and Juan de Oñate ES closed when Del Norte ES opened.

The district is rebuilding Lincoln ES, which is scheduled to open in 2019. The old school will be demolished. Roosevelt ES will close and be demolished. Roosevelt ES students will be reassigned to Lincoln ES.

The district is considering closing Rocky View ES and redistributing the students to Red Rock ES and Jefferson ES. Tohatchi HS has significantly lower enrollments than in past years, and are considering right sizing the school. These projects have funding for feasibility studies scheduled in 2019/20.

The district approved a boundary adjustment in 2014, but it was not fully implemented. ARC has proposed new boundaries for the elementary schools. The district will present boundary adjustments to the public for comment prior to approval by the School Board during 2020.

In August 2018, McKinley Academy opened, creating an opportunity for students to earn both a high school diploma and dual college credit. Since the program is housed at the University of New Mexico Gallup campus, no additional facilities were added to GMCS.

## 2.2 Site / Facilities

#### 2.2.1 Location

### 2.2.2 Existing Site / Facilities

The district has over 2.4 million square feet of permanent facilities, and over 65,000 square feet of portable facilities in school and administrative facilities on about 760 acres. Exhibit 2-4 includes an inventory of all district sites and facilities.

School sites comprise 2.4 million square feet in permanent buildings and 60,000 square feet in occupied portable buildings on 728 acres. The district has land leases with the Navajo Nation for schools located in Navajo, Crownpoint, Tohatchi, Twin Lakes, Tse'Yi'Gai, Thoreau, and Chichiltah.

Administrative facilities comprise 130,000 square feet of permanent buildings and 5,000 square feet in portables on 29 acres of land.

The district owns teacher housing in five communities. It also owns vacant facilities and stored portables throughout its area.

The district has some vacant, undeveloped



land.

School facilities range in age from 0 to 67 years, and facility age distribution is fairly evenly spread. The district is addressing the replacement of three or four facilities in each five-year FMP span, in an effort to keep pace with the aging of buildings over their life cycles.

#### Facility Size

The size of many schools in the district is large, providing a high GSF per student when compared to the state adequacy standards (as shown in the *New Mexico Public School Adequacy Planning Guide, Appendix A: Maximum Building Gross Square Footage [GSF] per Student* and the PSFA GSF calculator workbook). The table in Exhibit 2-3 compares the actual GSF / student for district schools with PSFA's GSF / student to adequacy. It compares the current size of the school with the maximum school size for a new school with the same enrollment.

The excess GSF over adequacy districtwide, or the difference between the existing school size and maximum PSFA school size, is 815,918 GSF. This size is reduced from the size given in the previous Facilities Master Plan due to the demolition of Washington ES and the removal from service of some portables. However, the continued decline in overall enrollment also reduces the amount of GSF needed for many schools.

Continued cost savings of up to \$3.2 million annually is possible if the district continues to reduce the size of schools to meet adequacy standards.



## 2.3 District Growth

This section discusses growth trends in the district, including demographic, economic, and development factors that may impact district educational programs and student enrollment.

#### 2.3.1 Introduction

This section provides an analysis of historic and projected enrollment.

We use enrollment projections, along with classroom utilization patterns, to identify:

- Future classroom needs
- Future site capacities

### 2.3.2 GMCS Area Growth Trends

Gallup-McKinley County Schools is the largest school district in land area, with 4,957 square miles and the sixth largest district in enrollment out of the 89 districts in New Mexico. Total enrollment has declined gradually over the past 15 years. Over 75% of the students in the district attend schools in Gallup, and the rest are distributed in

Crownpoint, Navajo, Ramah, Thoreau and Tohatchi subareas. All subareas have experienced enrollment decline. With Navajo-Gallup Water Supply Project providing San Juan River water to many of the communities in the district around 2023 and with proposed economic development, the district has some enrollment growth potential in the long run. However, current demographic factors, the state of the economy, slow housing starts, and enrollment trends lead us to expect enrollment will continue to decline slowly over the next ten years.

#### Demographics

- Population in the city of Gallup has grown each decade for 100 years. It grew by nearly  $\bigcirc$ 1,500 persons from 2000 to 2010.
  - McKinley County's population grew each decade for 90 years. It reportedly declined between 2000 and 2010, but Census estimates mild growth from 2010 to 2017.
  - The school district had a comparatively young population in 2010, with median age of 31.9 years compared to 36.7 years for the state as a whole.
  - The increase in Native American population in Gallup indicates in-migration, particularly from the Navajo Nation.
  - Births and birth rates in the area have declined sharply since 1990, and are approaching state and national rates.

#### Economics

- Some major employers added jobs in recent years, including Gallup Indian Medical Center and Fire Rock Casino.
  - Gallup is the employment hub of county, strong in travel, trade and tourism, including retail, medical services, and lodging (new hotels, restaurants and Indian jewelry outlets).

Gallup had substantial new building in 1990s and much of 2000s; the number of issued residential permits has not recovered since 2009; additional phases of existing subdivisions can build and proposed residential projects may develop.

County employment declined from 2008 to 2017, with a slight recovery in 2015.

- The wages paid for new jobs do not equal the wages for lost jobs.
- The county lost jobs in public sector and mining but rose in healthcare.
- The unemployment rate is falling slightly, but still high.

#### Economic Development

- The Navajo-Gallup Water Supply Project proceeding and should reach Gallup in 2023, enabling growth and development.
- The widening of U.S. 491 improves accessibility in the district.
- Gallup Land Partners' Energy Logistics Park is beginning to develop.
  - Greater Gallup Economic Development Corporation is promoting and coordinating target industries.
    - The area's 135 miles of hiking/biking trails spurs some tourism spending and plans are to expand them further.

#### Enrollment

- Since 2000, the district has experienced a slow long-term decline in total school enrollment at an average annual rate of -1.2%.
  - Gallup, Ramah and Crownpoint area school enrollment has slowly declined.
  - Thoreau, Tohatchi and Navajo school enrollment has declined significantly. Pre-K enrollment has grown, but in 2016/17 is smaller than in the prior seven years due to a change from half-day to a full-day program.
  - Kindergarten enrollment has been generally steady, while births five years prior declined.
  - Bureau of Indian Education and private school enrollment within the district has declined.





## 2.4 Enrollment


While the district remains one of the largest in New Mexico, its enrollment has generally declined.

### 2.4.1 Historic Enrollment

The district lost 2,185 students, or -1.1% per year on average from 2000 to 2016.

Since 2001, total education enrollment declined by an average of 114 students per year, and basic education enrollment declined by an average of 60 students per year. Pre-Kindergarten enrollment declined between the 2015/16 and 2016/17 school years to less than 400 with the change from a half-day to a fullday program.








Exhibit 2-10 GMCS HS Assignment Areas

Exhibit 2-11 ES Assignment Areas





Exhibit 2-12 ES Assignment Areas in Gallup





Exhibit 2-13 MS and HS Assignment Areas in Gallup

Exhibit 2-14 Detailed Map of HS Assignment Areas in Gallup





#### Exhibit 2-17 East Gallup ES Enrollment Chart






#### Exhibit 2-18 West Gallup ES Enrollment Chart








#### Exhibit 2-25 GMCS Enrollment by Other District Subarea Chart GMCS ENROLLMENT BY SUBAREA: 2006-2019


#### Exhibit 2-26 Crownpoint Schools Enrollment Chart



#### Preschool

#### Charter Schools Enrollment

Enrollment in the two state-chartered schools located in the district, Dził Ditł'ooí School of Empowerment, Action, and Perseverance and Six Directions Indigenous School, totaled 99 in the 2018/19 school year. Uplift Community School, which had 179 students in April, 2017 closed at the end of the 2016/17 school year. GMCS helped the charter school place its former students.

#### Grade Change Ratios

Cohort survival ratios show the relation between students succeeding from one grade to the next grade in the following year.

A ratio of 100% means the same number of students in a class succeeds to the next grade the following year. Students entering grade 1 averaged the lowest ratio, at 96.2%.

ARC uses cohort survival ratios to project enrollment, described in the following section.

#### 2.4.2 District Enrollment Projections

District enrollment projections use the cohort survival method. This method tracks the number of students in a cohort (a group of students of a certain age who move together through one grade level to the next) through past grades. Calculation of survival rates (ratios of the number of students who remain from one year to the next) is based on historical enrollments. Calculation of future enrollment uses prevailing birth rates (for kindergarten) and average survival rates (for other grades). We adjusted ratios to reflect major factors identified during the growth analysis.


We prepared three enrollment projection scenarios, based on historical trends and expectations for future growth.

Low Range — uses the averages of survival ratios for the district from 2014/15 to 2016/17 (two years), assuming slower births, net out-

migration and a poor economy during the projection period. The average annual rate would be -1.8% over ten years.

Mid-Range — (most likely) uses the averages of survival ratios for each school from 2011/12 to 2016/17 (six years), assuming that births continue to decline somewhat, pre-K remains at approximately the 2016/17 level and trends stabilize in Gallup as some economic development measures succeed. The average annual rate would be -0.8% over ten years and -1.0% over 5 years.

**High Range** — uses the average of survival ratios for the district for the selected years of 2007-08, 2008-09 and 2015/16 (three years), and assumes some increase in pre-K over 2016/17, stabilization in births, and an improved economy that both stems outmigration and brings in some additional families. The average annual rate would be -1.1% over ten years.





#### Exhibit 2-34 Enrollment Projections by Grade



#### Enrollment Projections by School Level

ARC expects these average annual rates of decline in enrollment over the next 10 years: elementary schools, -2.9%; and middle schools, -1.2%. Meanwhile, high schools experience an annual growth rate of 1.8%. By school level, ES's are expected to have 1,100 fewer students in 2026-27 compared to 2016/17; MS's will have 268 fewer students, and HS's, 631 more students.

The projected growth in high school enrollment is the result of slight increases in elementary enrollment in the early 2010s that will progress through the high school during the projected years. High school enrollment will likely begin to fall, similar to elementary and middle school enrollment after 2028.

#### Conclusion

# 2.5 Utilization and Capacity

This section identifies:

- Existing and projected classroom needs to accommodate projected enrollment
- Student capacity of each school site
- Special factors influencing classroom use
- Strategies to accommodate district needs

# 2.5.1 Existing and Projected Utilization and Classroom Needs Analysis

No significant changes, as all the schools except for Turpen ES and Red Rock ES have seats available. See Exhibit 2-48.

# 2.5.2 Special Factors that Influence Facility Use

## Transfers and Boundary Areas

There are no significant changes to the current boundaries or transfer policy.

Roosevelt ES and Lincoln ES school boundaries will merge in the fall of 2019.

The district is considering districtwide boundary adjustments for 2020/21. It is required to hold public meetings and receive additional input before making these changes. Ongoing studies will determine whether enrollments at Roosevelt ES and Lincoln ES can be combined at the new Lincoln ES site, and whether Indian Hills ES, Jefferson ES and Red Rock ES can absorb the students from Rocky View ES.

## Programs and PTRs

Program delivery follows the state-mandated pupil / teacher ratios (PTRs) for general and special education programs.

The Educational Specifications for Gallup-McKinley County Schools Elementary Schools (revised October 2012) describe elementary school program sizes:

GMCS wants to preserve the small enrollments and closeness of community, staff, students and parents that is the product of such a school. GMCS elementary schools range in size from 204 to 326 students, and are comprised of about 50 to 60 students per grade level in three team levels.

GMCS requires the maximum number of students within kindergarten classrooms to be no more than 20, and for grades 1 through 5, no more than 24 students.

All elementary schools include a preschool (3Y and 4Y IEP) program and nine elementary schools have a state grant for the 4Y pre-K program. The program schedule is a Monday-through-Thursday program, with Fridays off. The PTR for the preschool program follows PED requirements, and limits enrollment to 16 students per classroom. The PTR for the state grant for pre-K allows a maximum of 20 students per classroom. State adequacy standards for kindergarten classrooms apply to preschool facilities, and Early Childhood Environment Rating Scale (ECERS) requirements for program evaluation apply to the state pre-K program facilities.

All elementary schools include a Navajo language and culture program. Some elementary schools require space to expand the program to serve grades 3, 4 and 5.



Special education programs are a fullinclusion programs districtwide. The district has some "hubs" for services, which lowers the PTR for instructional spaces for these programs, as follows:

- Indian Hills ES hosts a hearing program
- Jefferson ES hosts a vision program
- Del Norte ES and Catherine A. Miller ES host a high needs and cognitive impairments program
- Red Rock ES hosts a cognitive impairments and autism program

Young adults receive services at their local high schools.

# 2.5.3 School Site Capacity

See Exhibits 2-47 through 2-50 for the functional capacity compared to the 2018/19 40-day student enrollment. This comparison does not include use of portables.

All sites have the capacity for additional students, except for Turpen ES and Red Rock ES. The two schools are at capacity, but future enrollment is not expected to increase. Future boundary adjustments and a new school facility take into account Red Rock ES students' space needs.


#### Exhibit 2–47 Elementary School Capacity







# 2.5.4 Strategies to Meet Needs

The FMP process considered questions about replacement or renovation; system upgrades as capital projects or maintenance; strategies for schools with excess GSF; and school closure and consolidation.

Gallup middle schools and high schools have excess capacity, but the facilities are not large enough to accommodate consolidation. The facilities are not configured to enable closing a building or wing.

The district plans to replace Gallup HS due to structural failures of the current building. It can rebalance enrollments for the three Gallup-area high school programs and size the new facility to meet projected enrollment at that time.

The district would like to consolidate and replace most of the buildings at Tohatchi High School to better addresses the student population. Some of the newer facilities could remain and be integrated into the new design.

The high schools in Crownpoint and Navajo have capital needs, and the district can address issues of excess GSF and capacity during future renovations or rebuilding.

# 2.5.5 Spaces Underutilized or To Be Demolished

The steering committee discussed opportunities to reconfigure existing programs and close facilities to improve school utilization throughout the district. The configuration of facilities limits opportunities to reduce GSF at most schools.

The Tohatchi HS campus is comprised of separate buildings and wings. Currently, the school has closed the 300 Wing to save operational costs and improve utilization.

Tse'Yi'Gai HS has expanded its program to accept 8th grade students. The school is distant from other district schools, and options to improve utilization are limited. To improve utilization, the district can add additional middle school grades, or close the school.

The community does not support accommodating grades 7 through 12 programs at the Crownpoint, Navajo or Tohatchi schools as a single entity, but some shared facilities are acceptable.

Vacated facilities that result from replacement and consolidation of elementary schools are as follows:

- Juan de Oñate ES is closed and the property and land have been sold.
- Lincoln ES will be demolished when the school is replaced. The new Lincoln ES is scheduled to open in fall 2019.
- **Ramah ES** will be removed from the district inventory and is scheduled for demolition.
- **Thoreau ES** is under contract for a new building. The old building and all vacant structures on site will be demolished when

the school is replaced.

- **Red Rock ES** will be demolished when the school is replaced. The project will require a PSCOC award.
- The district is considering options for **Roosevelt ES**, which will close when Lincoln ES is replaced. Students are scheduled to move to the new Lincoln ES in 2019. Options include demolishing the facility and expanding parking for the district stadium, or relocating a Gallup program to the facility to avoid renovation of a different facility.
- Washington ES has been demolished.
- A paint shop across the street from the **Gallup MS** campus is vacant and requires demolition.

The Crownpoint MS and HS campus has vacant buildings, an old auxiliary gym and a vocational building which require demolition.

Districtwide, additional vacant buildings need to be demolished, and abandoned and condemned portables demolished or scrapped.

The district demolished the old teacher housing at Thoreau HS, Crownpoint HS, Tohatchi, and Navajo Pine HS.

# 2.8 Capital Funding

This section summarizes total capital needs identified by the district, addressing growth, renewal of existing facilities, technology, and educational and programmatic requirements.

# 2.8.1 Capital Funding History

Gallup-McKinley County Schools funds its capital improvements program through several funding sources, including:

- General obligation bonds (G.O. bonds)
- SB-9 funds, or 2-mill levy (Public Schools Capital Improvement Act)
  - The State matches SB-9 local funds each year for general maintenance and small projects
- PSCOC funds
  - Standards-based awards

- Systems-based awards
- Emergency assistance
- Systems Initiative Program
- Broadband Deficiency Correction Program (BDCP)
- Federal Impact Aid
- E-rate Grants

The district does not use HB-33 funding (Public School Buildings Act) or Educational Technology bonds. These programs would reduce the available bonding capacity of the district.

Exhibit 2-51 shows PSCOC funding awards since 2015. The state share of construction costs is 80% and the district share is 20%. Award amounts may vary from actual expenditures for the projects.

## 2.8.2 Resources Available

Using RBC Capital Markets projections for bond proceeds and levy revenue, and district estimates for Federal Impact Aid allocations for construction, ARC calculated the anticipated future financial resources available by year to meet capital needs. The five-year capital plan anticipates about \$38.5 million of local funding for projects, which can be rounded up to \$40 million for planning purposes.

In February, 2017, McKinley County voters authorized \$25 million in general obligation bonds for capital improvement projects with 77% approval. The district currently is 93.7% bonded to capacity and has a current debt capacity of \$3,000,000. (Source: GMCS Capital Funds Analysis, prepared by RBC Capital Markets, 12/21/2018) After the district's August 1, 2019 principal payment, its capacity will be approximately \$8,500,000.

The next SB-9 (2-mill levy) election will be in 2022. The levy is renewed through election every six years.

Federal Impact Aid is funding in lieu of local property taxes for children residing on federal lands. For planning purposes, the district will allocate about \$60,000 per year for capital improvements. PSCOC will likely provide funding for replacing additional GMCS schools. See Exhibit 3-3. PSFA ranks each school facility with respect to all other facilities in the state, and assigns a condition index value (wNMCI). The school list starts with the greatest need (lowest ranking number) and continues to the least need (highest ranking number) according to the state system. Note that PSFA does not rank administrative or support facilities, and PSCOC does not fund capital projects for those facilities.

GMCS has four schools in the top 50 of the list, and an additional three schools in the top 100. Standards-based awards will fund projects at an 80% state share and 20% local share.

# 2.8.3 Scope and Estimated Cost of the 2017–22 Capital Plan

The 2017-22 FMP has identified about \$88 million in district prioritized needs. The district's resources are not capable of matching these needs.

The district resources of \$40 million over five years relies on the partnership with PSCOC for capital projects to meet facility capital needs.

GMCS has raised concerns with PSCOC about a lack of state funding for facilities not included in adequacy standards. District resources are not capable of matching needs for facilities at full cost to the district. The district has expressed a desire for the state to participate in:

- 1. Constructing Title IX athletic amenities to accommodate both sexes
- 2. Extending utilities off of site
- 3. Constructing concession stands
- 4. Constructing Navajo language classrooms
- 5. Constructing cultural classrooms
- 6. Constructing parent education spaces
- 7. Constructing "response to intervention" spaces
- 8. Constructing OT/PT spaces

- 9. Constructing computer-based testing spaces
- 10. Installing minimal landscaping
- 11. Constructing teacherages
- 12. Constructing softball and baseball fields
- 13. Paying Navajo Business Activity Tax
- 14. Providing additional funding for facility maintenance
- 15. Revising the state-district match

# 3 Capital Improvement Plan

This section summarizes total capital needs identified by the district, addressing growth, renewal of existing facilities, technology, and educational and programmatic requirements.

# 3.1 Total Capital Needs

The total capital needs for all school, administrative and support facilities are \$262 million. Exhibit 3-1 summarizes the capital needs of district facilities. The original FMP Appendix includes a full facility description, summary of renewal requirements and detailed capital improvement needs.

Capital improvement projects (CIPs) are project estimates which address facility condition and adequacy deficiencies, programmatic and growth needs, and sustainability upgrades and opportunities. Each CIP includes a project description and budget which corrects the facility need.

Capital needs show the budgets to correct deficiencies. High capital needs typically reflect life cycle need(s) for systems renewal or replacement, such as HVAC or roofing systems. The high needs may also reflect larger facility size. Lincoln ES shows a cost for the replacement school facility.

## Sources of Funding

The district uses sources of funding listed below for maintenance, capital projects, and for broadband (Exhibit 3-2).

#### Preventive Maintenance Needs and Resources

The district's Preventive Maintenance (PM) Plan 2018/19 goals and procedures articulate how the district will identify and rectify preventive maintenance needs and how the district measures maintenance effectiveness. The district updates the PM plan annually.

The size of the district geographically impacts district costs for preventive maintenance. The district has 16 sites at a distance greater than 30 miles from the central maintenance office, adding time, wear on vehicles, and challenges to each effort.

The district's capital funding strategy includes major planned maintenance and repair projects. The total anticipated preventive maintenance needs of prioritized projects is \$29 million. The G.O. bond program, exclusive of SB-9 funds for the maintenance program, provides \$11.45 million in funding for maintenance capital improvements. PSCOC funding is anticipated for HVAC improvements through the Systems Initiative Program. The list of prioritized projects is included in the capital plan (Exhibit 3-4).

#### **Decreasing Enrollments Requirements**

Declining enrollment has created a legacy of school facilities around the district with capacities larger than the current and projected enrollments.

In the county communities, the high school facilities generally show the highest needs for capital improvements and investments. The steering committee considered renovation and replacement of facilities, and found renovation to be more cost-effective to bring schools up to a state-of-the-art condition, while allowing the community to retain the larger gyms and classrooms. To improve utilization, the district



will need to resize schools during this process, or work with the communities to reconfigure school programs into fewer facilities.

In the Gallup area, declining enrollments will require boundary area adjustments for elementary schools. The adjustments will establish the design enrollment to rebuild Red Rock ES and for the possible repurposing and renovations at Rocky View ES.

## Facilities Recommended for Replacement

Lincoln Elementary School and Thoreau Elementary School

Lincoln ES is funded for replacement as part of the 2011-2016 GMCS FMP capital plan and through PSCOC project #15-007. The replacement school is designed, and the project is scheduled for completion in 2019.

Thoreau ES is funded for replacement as part of the 2011-2016 GMCS FMP capital plan and through PSCOC project #15-006. The replacement school is in the design phase, and the project is scheduled for completion in 2019/2020.

#### Red Rock Elementary School

The Red Rock ES facility is at the end of its useful life. Major building systems, including plumbing, roofing and HVAC are in poor condition. The school's hexagonal configuration limits flexible use of spaces, and corridors are narrow with poor sight lines. The kitchen has a small serving area, limiting function. The school has eight portables in use that serve preschool, upper grade classes and special education, and analysis shows a classroom need. Vehicular circulation is congested. The facility should be replaced rather than renovated.

A feasibility study for replacement is scheduled for 2019/20.

Red Rock ES is ranked #27 on the 2019 preliminary state list, with a NMCI of 49.31%. State participation in funding for a replacement school is likely during this 5-Year FMP cycle.

#### Gallup High School

Gallup HS was built in 1998 and 2009, and while not an old facility, the building systems are failing, including the foundations, HVAC, plumbing and drainage. In 2016, the district was required to invest over \$2 million in structural and drainage repairs at the gym lobby, and hopes to avoid ongoing costly structural repairs to the failed facility. The HS has excess GSF and capacity, and with replacement of the facility, the district has the opportunity to "right-size" Gallup area HS facilities to align with projected enrollment.

Gallup HS is ranked #29 on the 2019 final state list, with a wNMCI of 46.29%. State participation in funding for this program during this 5-Year FMP cycle is possible.

#### Gallup Central Alternative High School

Housed in a former elementary school, the Gallup Central Alternative HS is a facility at the end of its useful life. Building systems are in poor condition, including the building envelope and roofing, HVAC, electrical, plumbing, and interior finishes. The building has no fire suppression system, and facilities

are not ADA-compliant. The district will consider options to replace or relocate the program to another facility.

Gallup Central Alternative HS is ranked #23 on the 2019 final state list, with a wNMCI of 48.07%. State participation in funding for this program during this 5-Year FMP cycle is possible.

# Gallup Bus, Transportation, Maintenance and Warehouse Facilities

GMCS bus transportation center, and maintenance and warehouse facilities are in poor condition, require code upgrades, and do not meet the current needs of the district. The district recommends repurposing Rocky View ES and renovating the building and site.

Total capital needs for 700 Boardman Avenue is \$8.7 million, and for the existing bus transportation center is \$3.6 million. Replacement facilities, not including site acquisition, have a proposed project budget of \$4 million. A feasibility study for repurposing and renovating Rocky View ES is scheduled for 2019/20. A cost analysis will be included in the study.

#### Educational Development Center

Also housed in a former elementary school, the Educational Development Center (EDC) facilities are in poor condition and do not meet the needs of the users. EDC staff handle administration of the district's specialized education program. The general building condition makes it challenging for staff to perform their jobs. Work spaces are crowded and the encroaching stored items inhibit mobility. Ineffective HVAC systems and constant building maintenance take focus away from the staff assisting students and learning programs. The district will consider options to renovate or relocate the program to another facility.

#### Facilities Recommended for Major Renovations

#### Rocky View Elementary School

Rocky View ES was built in 1994 and has capital needs for general renovations and major building systems upgrades, including roofing, HVAC and a fire suppression system. The feasibility study will consider placing students in other schools and repurposing the school for Transportation and Maintenance.

Rocky View ES is ranked #18-19-25 on the 2019 final state list, with a wNMCI of 70.23%. The State is participating in the feasibility study. Pending results of the study, state participation in funding for a replacement school on this site or elsewhere is likely during this 5-Year FMP cycle.

#### Navajo Pine High School

The Navajo Pine HS facilities were built in 1985, and the roof was replaced in 2014. The building requires general renovations and upgrades to HVAC and restrooms. The declining enrollment has created a legacy of excess GSF. The configuration of the building does not support demolition or closing of a portion of the facilities. Renovation of existing facilities is more cost effective than construction of a new replacement high school. The district will work with the community to address excess GSF and consider strategies to improve utilization.

Navajo Pine HS is ranked #98 on the final 2019 state list, with a wNMCI of 37.35%. State participation in funding for renovations of the school is likely during this 5-Year FMP cycle.



#### Tohatchi High School and Middle School

Tohatchi HS facilities were constructed in 1978 and 1984, and need major renovation and refurbishing. The gym received a new roof in 2011. The school is comprised of four separate buildings with separated wings, a configuration which allows phased renovations on an occupied campus.

The district is considering rebuilding part of Tohatchi High School to reduce excess square footage. The State is participating in a feasibility study in 2019/20 to explore the possibilities and costs associated with renovation, demolition and consolidation.

Tohatchi HS is ranked #18-19-28 on the 2019 final state list, with a wNMCI of 36.56%.

State participation in funding for projects, including demolition, renovations or partial replacement of the school is possible during this 5-Year FMP cycle.

#### Thoreau High School

Thoreau HS was built in 1980 and the roof was replaced in 2012. The building requires general renovations and upgrades to HVAC and site needs. The declining enrollment has created a legacy of excess GSF. The configuration of the building does not support demolition or closing of a portion of the facilities. Renovation of existing facilities is more cost-effective than construction of a new replacement high school. The district will work with the community to address excess GSF and consider strategies to improve utilization.

Thoreau HS is ranked #183 on the state list, with a wNMCI of 31.58%. State participation in funding for renovations of the school is not likely during this 5-Year FMP cycle.

#### Crownpoint High School

Crownpoint HS opened in 1973, and the roof was replaced in 2013. The facility requires major renovations and replacement of HVAC systems and plumbing. The HS and MS campus includes several vacant buildings, including the old auxiliary gym, and vocational building. The district will work with the community to address excess GSF and consider strategies to improve utilization.

The district needs a campus master plan to guide investments and demolition on the site.

Crownpoint HS is ranked #69 on the 2019 final state list, with a wNMCI of 39.87%. State participation in funding for renovations of the school is possible during this 5-Year FMP cycle.

#### **District Stadium**

The restroom and press box facilities were built about 1980 and are not ADA-compliant. Site improvements are needed at the track and field and parking facilities.

Total capital needs for district stadium facilities is about \$4 million.

## System Upgrades

Several elementary schools have code issues due to a conflict between the fire codes and the cooling system. Chee Dodge ES, David Skeet ES, Indian Hills ES, Stagecoach ES and Tobe Turpen ES were built prior to the requirement for a fire suppression system and are "grandfathered" to allow a one-hour rated corridor instead. However, the evaporative cooling system requires that classroom doors remain open, violating the one-hour corridor rating. The district can resolve the code issue by installing a fire suppression system or replacing the cooling system.

#### Facilities To Dispose Of

The district disposed of about 56 units of vacant teacher housing, about 90,000 GSF.

The district will have about 92,000 GSF of closed school facilities for disposal at Juan de Oñate ES, Ramah ES and Roosevelt ES. Options for disposal of facilities include:

- Give away facilities
- Repurpose facilities to avoid renovation of other older facilities
- Demolish facilities

Roosevelt ES could be demolished to provide additional parking for the district stadium in Gallup.

Crownpoint MS and HS has vacant buildings, comprised of closed school buildings and portables. The two schools have excess GSF.

Districtwide, ARC has inventoried 44 unusable portables, over 48,000 GSF, on school campuses. Some sites store portables or use vacant portables for storage. Gallup MS, Crownpoint HS, Navajo Pine HS and Thoreau HS have abandoned portables.

# 3.3.1 Summary Table of Priority Capital Projects

Prioritized District Funds for 2019/20 include the following:

- Playground updates at Catherine Miller ES, Jefferson ES and Indian Hills ES
- HVAC Systems are districtwide as needed
- Drainage upgrades at Gallup HS
- Plumbing upgrades are distictwide as needed
- Roofs are districtwide as needed
- Feasibilty studies for consolidation, repurposing and demoliltion of schools

#### PSFA FAD-ranked schools

The capital plan includes a strategy for all top eligible FAD-ranked schools on the PSFA list. Exhibit 3-3 shows the 2019 preliminary state ranking for the entire district; 18 schools moved further up in the PSFA rankings, while 14 schools moved down. The most significant movement is reflected in Navaho Pine HS, Thoreau HS, Stagecoach ES and Tobe Turpen ES. PSCOC considers the top 100 schools for significant renovation or replacement. It considers the top 200 schools for systemsbased funding. Thoreau HS dropped in rankings, removing it from the standardsbased funding consideration list at this time.

## 3.3.2 Financial Strategies and Alternatives Considered

The FMP Capital Plan is subject to review and revisions, depending on the success of the district in partnering with PSCOC in renewal projects and systems upgrades. There



is no guarantee that the district will generate the planned revenues. The district may modify the recommended project priorities to bundle similar projects to generate savings or respond to unforeseen construction conditions, material availability or costs.


