SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

House Bill 401 (HB401) changes the title of Chapter 22, Article 15A NNMSA 1978 from Technology for Education Act to Digital Equity in Education Act. The bill removes the definition for "bureau," and "chief," changes the definition of "educational technology," and adds the definitions for "large school district" and "small school district."

Section 3 alters the responsibility from the Bureau to PED to administer the Digital Equity in Education Act, and removes paragraph B in its entirety, regarding the development of the statewide plan for integration of educational technology into public schools. It also adds that the PED shall "require," rather than "assist," districts and charter schools to develop, implement and submit the educational technology plans, and further details what shall be included in the plan.

At Section 5, the amends the requirements for the Council on Technology in Education to include 13 members, rather than 17, who shall be appoint by the PED. It further changes the amount of members whose terms expire at the specified times, and specifies requirements on who the PED shall appoint.

The bill makes minor amendments throughout for consistency.
